1. Maharashtra Mandal London is most grateful for your generous donation.
2. Your contributions by way of donations could be worth substantially more to the Mandal at absolutely no extra cost to you. We qualify for Gift Aid rebates at the basic rate of income tax from Inland Revenue. If you are a UK taxpayer, currently (2008/09) we receive 25p for every £1 you give. If you pay tax at a higher rate of 40% you can claim tax relief between the basic and the higher rate, thus reducing the cost to you.
3. The Government will pay to the charity an additional 3p on every £1 you give between 6 April 2008 and 5 April 2011. This transitional relief for the charity does not affect your personal tax position.
4. You must pay an amount of income and/or capital gains tax at least equal to the tax that the Mandal reclaims on your donations in the appropriate tax year, currently 25p for every £1 you give.
